In consideration for receiving permission to participate in the volunteer program at Spirit Acres, I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE, Spirit Acres their officers, agents, servants or employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or any of the property belonging to me, or while in, on or upon the premises here the program is being conducted.
2. I am fully aware of the risks involved and hazards connected with this program. I hereby elect to voluntarily participate in said program with full knowledge that said program may be hazardous to me. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or any loss or damage of property owned by me as a result of being engaged in such program WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE.
